“Happiness is having a HOME to enjoy” was handwritten on the back of an envelope Steven Boyd sent to our office. He included a smiley face and the words “Me” under his message. Steven, who lived on the streets for two years before becoming housed through our Leasing Assistance Program, says, “I am still sober and alive because of this housing program.”



The key for Steven was finding a safe, affordable apartment where he could lay a new foundation for his life off the streets. Welcome home, Steven!

Angel Wise, a veteran, fell behind on her house payments after becoming disabled. She was referred to us through the V.A. with the hope of saving her long-time and much-loved home. One of the team members in our Foreclosure Prevention Counseling program worked with her on all of the paperwork as well as the lending company procedures. The key for Angel Wise was being able to keep her home with a mortgage payment she could afford. Welcome home, April!

Pauletta Carson, a case assistant at the Oakland County Friend of the Court, long dreamed of owning her first home. The life-long Pontiac resident wanted to raise her family while remaining in her hometown. She qualified for one of the homeownership opportunities afforded by our Unity Park development with newly built single-family homes. The key for Pauletta Carson was in being able to realize her dream come true in a neighborhood of her choice and with a price she could afford. Welcome home, Pauletta!

The key to everyone's front door is as different as the varied needs of those seeking a safe, affordable place to call home. Our work is done one front door at a time, utilizing many sources with individually tailored approaches.

There are many phases and programs supporting our work providing keys that open doors and transform lives.

Together with our community partners and supporters, in 2014 we:

Announced our largest development ever with news we will be constructing Grafton Townhomes, 48 townhome-style units, in Eastpointe. The \$11 million development is funded through a housing tax credit reservation through Michigan State Housing Development Authority (MSHDA). The development includes project based

vouchers, a mixed-income structure and 12 supportive housing units. Construction is expected to begin in spring 2015.

Neared completion of Unity Park Rentals, 32 scattered-site single family lease-to-purchase homes in Unity Park, Pontiac, along with a community building. The \$8.47 million development is funded through a housing tax credit reservation through MSHDA. The development included the creation of a Community Revitalization program in Unity Park, Pontiac, connecting residents to each other and to programs and services available in the community.

Launched the CHN Housing Hub blog, www.chnhousinghub.com, to share a tremendous amount of knowledge we continue to acquire in a wide range of housing issues that is useful for stakeholders, community partners, program participants, funders, donors and the media. CHN staff members contribute posts in their area of expertise in the six categories designed to be helpful for those looking for specific information: Fair Housing; Housing Crisis; Housing Policy; Housing Stability; Inclusive Communities; and Long-Term Housing Solutions.

Learned we were again receiving notable workplace honors by being named as one of the Detroit Free Press Top 100 Workplaces, for the third year in a row. For a second time, Community Housing Network was named one of Crain's Cool Places to Work. Both awards follow a survey of all employees and then a vetting process by each publication. We have been very intentional about the kind of culture we offer. CHN offers team members a lot of workplace flexibility. Creativity is encouraged and risk-taking is rewarded. This brings to us high quality people who appreciate our working environment, and I think that's what's reflected in the awards we've received.

Thank you for your ongoing partnership. We look forward to continuing our work next year and long into the future.

2014 Highlights

- **Honored** James Finley with the fourth annual Emmett Jones Memorial Award, which recognizes the hard work, perseverance and accomplishments of participants in Community Housing Network's programs. James, who was formerly homeless, found help through CHN's housing programs.
- **Presented** James C. Merritt with the inaugural James C. Merritt Volunteer Service Award for his extraordinary commitment and dedication to the mission of CHN. In addition, James served on our board of directors for more than a dozen years.
- **Remained** the largest permanent supportive housing provider in Oakland and Macomb counties, serving 516 people in the Leasing Assistance Program, including 163 children, previously homeless, in need and living with a disability. In addition, there were 75 people in Shelter Plus Care, a housing program offering additional supports, including 26 children.
- **Assisted** 18,517 individuals who contacted the Housing Resource Center call center with a wide variety of housing issues and questions. As part of the screening process and follow up linkage to programs, 1,209 individuals/households met with HRC Housing Specialist staff for face-to-face meetings to pursue housing resources. This included programs that could provide long-term stability for those with the most housing needs, including completion of web-based Homeless Preference Housing Choice Voucher online applications (262), completion of full Housing Choice Voucher applications after a waitlist pull (189 completed) and special need unit applications (248). In addition, program staff assisted with 37 applications for the Moving Up Voucher, a pilot program that offers program participants currently in permanent supportive housing to transition into a Housing Choice Voucher with less supportive services.
- **Constructed** and/or renovated 60 units of affordable housing for people in need, bringing the total number of rental units developed to 786 since 2001 (including current Leasing Assistance Program units). In addition, there are 48 units currently in the development process.
- **Provided** property and leasing management for 2,712 units of affordable housing serving as residences for people with disabilities in Oakland, Macomb, Wayne and St. Clair counties.
- **Hit** a milestone in our Wayne office as total assistance provided to CHN clients through the Step Forward Michigan mortgage and property tax assistance program exceeded \$1 million, which represents the preservation of \$8 million of real estate value. In addition, our foreclosure prevention services assisted 771 households experiencing mortgage or property tax delinquency.
- **Counseled** members of 451 households seeking to purchase a new home by providing homebuyer education.
- **Celebrated** eight people, five in Oakland County and three in Macomb County, who transitioned out of the Leasing Assistance Program and are now renting independently. In addition, there were 30 people, 24 in Oakland County and six in Macomb County, who exited the Leasing Assistance Program into housing with a rental subsidy. Also, one person transitioned out of the Shelter Plus Care Program housing program and is now renting independently and one person exited into housing with a rental subsidy.
- **Expanded** the Getting My Own Address (GMOA) program by reaching 777 people through presentations, two Oakland County support groups, individual counseling and networking opportunities. This included reaching people interested in the program at local, state and national levels. The GMOA Overview Presentation became part of the curriculum for the ARC of Michigan's Leaders in Policy Advocacy training and was presented in Lansing, Ypsilanti and Grand Rapids, with plans for future expansion across the state. The program was also presented at the Michigan Community Mental Health Boards conference and for the Lapeer Intermediate School District. Three local presentations were funded through a grant from the Autism Society Oakland County. Since September 2011, the GMOA program has served 3,522 participants.
- **Raised** more than \$100,000 through Bring it Home 2014, our annual event, attended by 356 people. More than \$20,000 of the funds raised that evening came through the live auction to benefit Adopt A Family.
- **Facilitated** 12 in-office preliminary and voucher briefings with assigned MSHDA Housing Agents as part of a new system to expedite the voucher processing for those pulled for MSHDA Homeless Preference Vouchers. This allowed for a higher success rate for potential program participants to lease up in units and sustain housing.
- **Attended** 490 community events through Community Program and Outreach. These events included workshops, presentations, vendor tables and networking opportunities. Presented at both the Building Michigan Communities Conference and Homeless Summit on work being accomplished through Community Program and Outreach.
- **Reached** out through Projects for Assistance in Transition from Homelessness (PATH) to 507 individuals who were homeless, of whom 194 were enrolled in the program after meeting eligibility criteria and providing consent. Assisted 16 program participants with limited funding available through this program to secure housing or meet related housing needs. Additionally 10 program participants were bridged to short-term financial assistance through Emergency Solutions Grant Rapid Rehousing, 16 program participants transitioned to permanent supportive housing, and 33 program participant applications were pulled from the 137 program participants who were assisted with applying for a Homeless Preference Housing Choice Voucher.
- **Wrapped** up the Working With Continuum of Care Bodies Program by providing continued accessibility by making the guide curriculum available on flash drives with assistive technology in multiple formats.
- **Supported** 760 individuals and families through our 2014 holiday season annual Adopt A Family program at the Troy and Wayne offices with an unprecedented \$34,559 in cash donations and \$51,925 in in-kind donations.
- **Served** 360 individuals in Oakland County through the Emergency Solutions Grant program providing limited financial assistance for housing and/or case management. This included 117 single adults, as well as households composed of 84 adults and 159 children. Of the 360 individuals, 50 households were served with Rapid Rehousing, providing financial assistance and services to help those who are experiencing homelessness to be quickly re-housed and stabilized. In addition, 19 households were served with prevention funding, which provided short-term rental arrearages and services to prevent those households from becoming homeless.
- **Grew** the Springhill Housing Corporation pooled accounts trust for 220 individuals to more than \$7 million.
- **Offered** volunteer opportunities totaling 10,865 hours. A significant amount of that time was contributed by four AmeriCorps members.
- **Served** in leadership positions on many boards and organizations including: the Federal Home Loan Bank of Indianapolis Affordable Housing Advisory Council; National Low Income Housing Coalition; Community Economic Development Association of Michigan; the Alliance for Housing, Oakland County's Continuum of Care; the Macomb Homeless Coalition; Opportunity Resource Fund; Furniture Bank of Southeastern Michigan; Autism Society Oakland County; Homes for Autism; Michigan State Autism Plan; Leadership Oakland; Leadership 21; Out Wayne County Homeless Services Coalition; Oakland County Community and Home Improvement Division Citizen's Advisory Council; OCCMHA Consumer Advisory Committee; Michigan Disability Housing Workgroup; PNC Community Development Banking Advisory Board; MSHDA Workgroup – Housing Assistance and Models; Building Michigan Communities Conference Planning – Ending Homeless Track; Oakland County Community Interagency Service Team; Oakland County PSH Partners Group; and others.

Community Housing Network, its affiliates and managed entities, have made a powerful impact on the community since it was founded in 2001. Community impact evidence is based on financial impact as well as numbers of people served. All figures are since CHN's inception, unless otherwise noted.
